


Figure 1. Max. Reverse Power Dissipation vs.
Junction Temperature




Figure 2. Reverse Current vs. Junction Temperature




Figure 3. Forward Current vs. Forward Voltage





Figure 4. Diode Capacitance vs. Reverse Voltage


