

The TELUX™ series is a clear, non diffused LED for applications where supreme luminous flux is required. It is designed in an industry standard 7.62 mm square package utilizing highly developed (AS) AllnGaP technology.

The supreme heat dissipation of TELUX™ allows applications at high ambient temperatures.

All packing units are binned for luminous flux, forward voltage and color to achieve the most homogenous light appearance in application.

SAE and ECE color requirements for automobile application are available for color red.

The above type numbers represent the order groups which include only a few brightness groups. Only one group will be shipped on each tube (there will be no mixing of two groups on each tube).

In order to ensure availability, single brightness groups will be not orderable.

In a similar manner for colors where wavelength groups are measured and binned, single wavelength groups will be shipped in any one tube.




Figure 1. Forward Current vs. Ambient Temperature




Figure 2. Forward Current vs. Pulse Length




Figure 3. Rel. Luminous Intensity vs. Angular Displacement




Figure 4. Relative Intensity vs. Wavelength




Figure 5. Relative Intensity vs. Wavelength




Figure 6. Forward Current vs. Forward Voltage




Figure 7. Forward Current vs. Forward Voltage





Figure 8. Relative Luminous Flux vs. Forward Current




Figure 9. Relative Luminous Flux vs. Forward Current




Figure 10. Specific Luminous Flux vs. Forward Current




Figure 11. Specific Luminous Flux vs. Forward Current




Figure 12. Rel. Luminous Flux vs. Ambient Temperature




Figure 13. Rel. Luminous Flux vs. Ambient Temperature




Figure 14. Thermal Resistance Junction Ambient vs. Cathode Padsize





Figure 15. Percentage Total Luminous Flux vs. Total Included Angle for 60° emission angle
