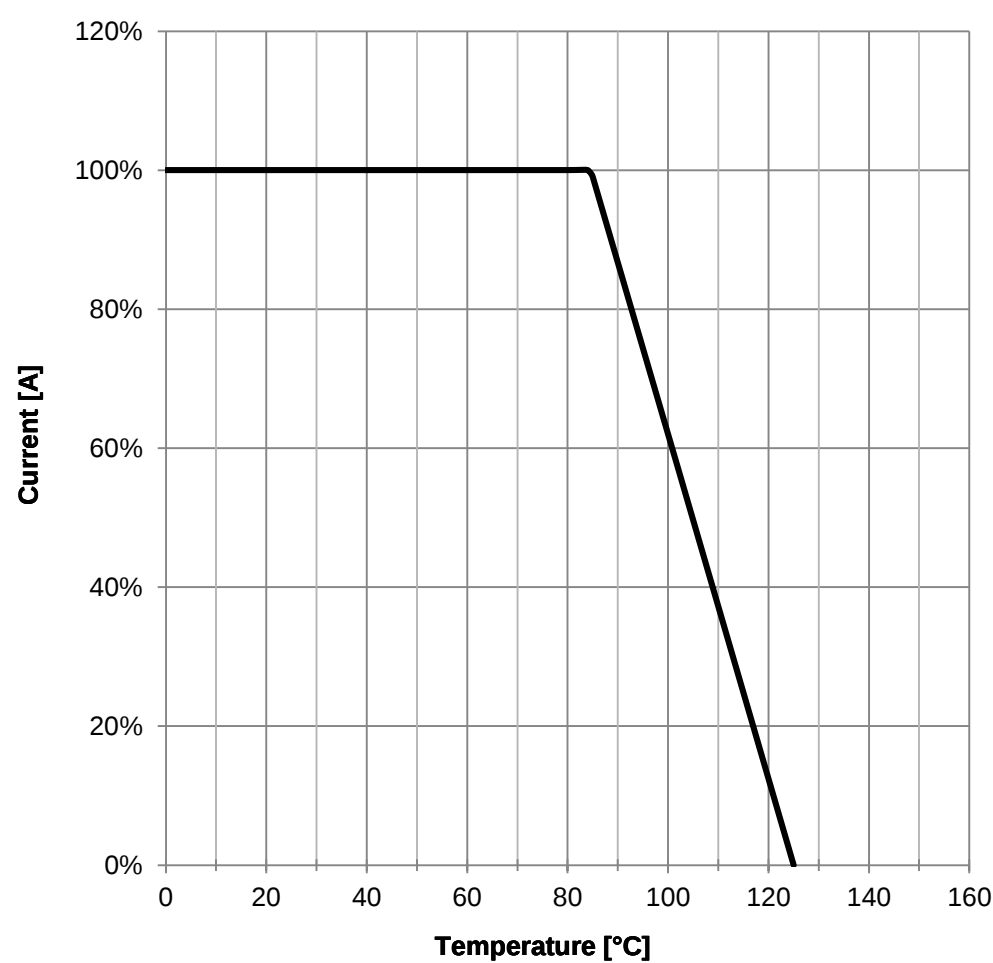

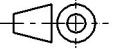
Typical Impedance Characteristics:



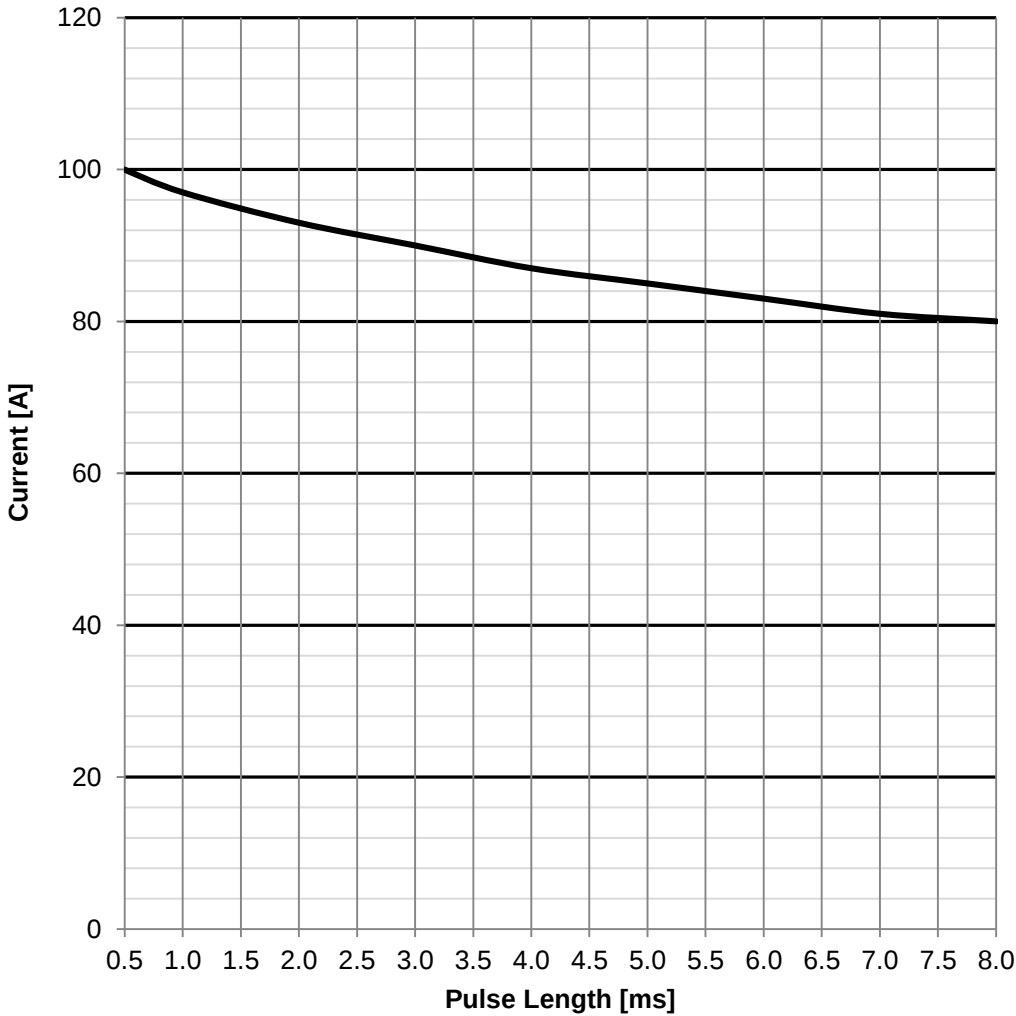
Derating Curve:

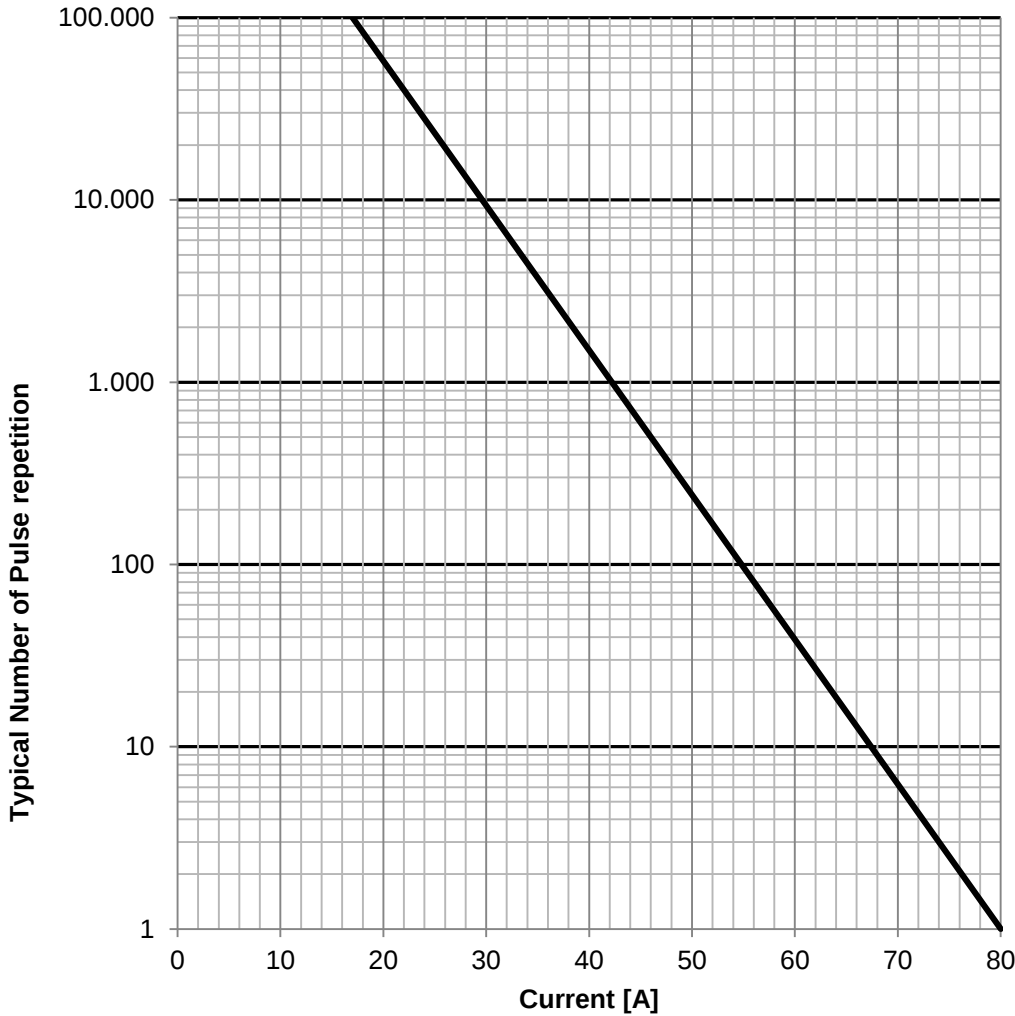

Typical Peak Current vs. Pulse Length Characteristics:



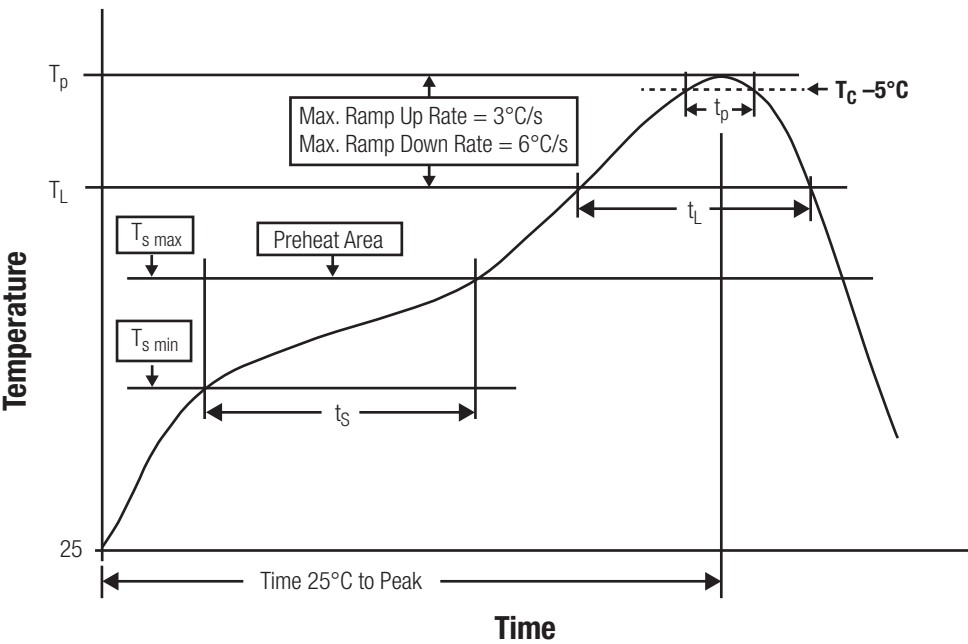
